**2. HAZARDS IDENTIFICATION SUMMARY**

**KEEP OUT OF REACH OF CHILDREN – CAUTION** – Causes moderate eye irritation. Harmful if inhaled or absorbed through skin. Avoid contact with eyes, skin or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse. Do not contaminate water used for irrigation, domestic or spray purposes.

This product is a light yellow oily liquid with virtually no odor.

**Warning Statements:**

**NOTE TO PHYSICIAN:** Petroleum distillate poses aspiration pneumonia hazard. Only minor irritation should be expected from any type of exposure other than pulmonary aspiration. Ingestion may result in some gastroenteritis and mild diarrhea. **4. FIRST AID MEASURES**

**If on skin or clothing:** Take off contaminated clothing. Rinse skin with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**5. FIRE FIGHTING MEASURES**

**6. ACCIDENTAL RELEASE MEASURES**

**STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:**

Eliminate all ignition sources. Avoid contact. Stop leak if without risk. Contain the spill (wear the proper PPE) by absorbing spilled liquid with clay or other absorbent material; scoop or sweep up material and place in container. Decontaminate area by washing with soapy water solution and absorbing the water with absorbent material. Check local and provincial regulations for proper disposal.

**CAUTION:** Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

**7. HANDLING AND STORAGE**

**HANDLING:** Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

**STORAGE:** Store in a cool, dry place. Store in original container. Keep tightly closed. If stored below 20°F / -6°C for an extended period, product may become cloudy and thicken.
