2. HAZARDS IDENTIFICATION SUMMARY

KEEP OUT OF REACH OF CHILDREN – WARNING - POISON – Corrosive. Causes irreversible eye damage. Do not get in eyes or on clothing. Harmful if swallowed, inhaled, or absorbed through skin. Avoid contact with skin. Avoid breathing spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Do not contaminate water used for irrigation, domestic or spray purposes.

This product is amber liquid with phenolic petroleum solvent-like odor.

Warning Statements:

4. FIRST AID MEASURES

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferable by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

5. FIRE FIGHTING MEASURES

FLASH POINT (°F/Test Method): Does not flash.

FLAMMABLE LIMITS (LFL & UFL): Not established.

EXTINGUISHING MEDIA: Use medium appropriate to surrounding fire. Dry chemical, carbon dioxide, foam, water spray or fog.

HAZARDOUS COMBUSTION PRODUCTS: Ammonia, oxides of nitrogen, chlorine-containing compounds and other unknown hazardous materials may be formed in a fire situation.

SPECIAL FIRE FIGHTING PROCEDURES: Wear self-contained breathing apparatus with full protective clothing. Fight fire from upwind and keep all non-essential personnel out of area of intense smoke.

UNUSUAL FIRE AND EXPLOSION HAZARDS: If water is used to fight fire and/or cool containers, contain runoff, using dikes to prevent contamination of water supplies.

6. ACCIDENTAL RELEASE MEASURES

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

Contain spill and absorb with suitable absorbent, sweep up material and transfer to containers for possible land application according to label use or for proper disposal. Wash spill area with water containing strong detergent, absorb and sweep up as above. Check local, state and federal regulations for proper disposal.

CAUTION: Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

7. HANDLING AND STORAGE

HANDLING: Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

STORAGE: Do not store below 25°F/-3.9°C. If frozen, warm to 70°F/21.1°C and redissolve before using by rolling or shaking the container. Store in a safe manner. Store in original container only. Store in a cool, dry place. Keep container tightly closed when not in use. Do not contaminate water, food or feed by storage or disposal.

Personal Protective Equipment: Applicators and other handlers must wear: long sleeved shirt and long pants, waterproof gloves, shoes plus socks, and protective eyewear. Follow manufacturer's instructions for cleaning and maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry. After each day of use, clothing or PPE must no be reused until it has been cleaned. **For containers over 1 gallon and less than 5 gallons in capacity:** Mixers and loaders who do not use a mechanical system (probe and pump) to transfer the product must wear coveralls or a chemical-resistant apron in addition to other required PPE.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

ENGINEERING CONTROLS: When handlers use enclosed cabs, or aircraft in a manner that meets the requirements listed in the worker Protection Standard (WPS) for agricultural pesticides [40 CFR 170.240 (d) (4-6)], the handler PPE requirements may be reduced or modified as specified in the WPS.

10. STABILITY AND REACTIVITY

STABILITY: Stable

12. ECOLOGICAL INFORMATION
