**2. HAZARDS IDENTIFICATION SUMMARY**

**KEEP OUT OF REACH OF CHILDREN – CAUTION - POISON.** Harmful if swallowed, inhaled, or absorbed through skin. Avoid breathing dust or spray mist. Avoid contact with skin, eyes, or clothing. Primary routes of entry are Inhalation, eye contact and skin contact.

This product is pale yellow powder with mild sulfur odor.

**4. FIRST AID MEASURES**

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

Avoid breathing dusts. Sweep up spills and transfer to approved chemical containers for disposal or rework. Keep dusting to a minimum. Check local, state and federal regulations for proper disposal. Check local or provincial regulations for proper disposal. Flush the area with water to remove any residue.

**CAUTION:** Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

**7. HANDLING AND STORAGE**

**HANDLING:** Do not smoke while applying this product. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

**STORAGE:** Keep away from heat, sparks or flame. Keep out of reach of children and animals. Store in original containers only. Store in a cool, dry place and avoid excess heat. Carefully open containers. After partial use, fold and roll back bags, clamp and close tightly. Do not put concentrate or dilute material into food or drink containers. Do not contaminate other pesticides, fertilizers, water supplies, food or feed by handling and storage of product.
