**Applications**

Aquamark WSP conveniently transforms pale, dirty or off-colored water to a sparkling blue. Aquamark WSP may be used to color ornamental lakes, ponds, fountains and other contained bodies of water. This product should not be applied to streams, rivers, outflows, or water not completely controlled by the user. Aquamark WSP may be applied to areas used for irrigation, but not for direct human consumption. Swimming and other recreation sports are approved during and following use of the product. Fish, waterfowl, and animals are not harmed by normal use of this product.

- Protect the packets from moisture prior to usage.
- Minimize handling to avoid breakage, and reseal the outer bags to protect unused packets.
- When handling packets, gloves are not required, but recommended to prevent blue dye from coloring skin.

**Directions**

Determine the volume of water to be treated, then consult the suggested use rate chart to determine the number of water soluble packets to use. If a darker or lighter color of water is desired, vary the rate accordingly. Simply toss or drop the correct number of packets into the water. Evenly spaced packets aid in quicker, more even coverage. Solubility typically occurs in 5 to 10 minutes, depending on water temperature.
