**DIRECTIONS FOR USE:** ADDIT™ Adjuvant is only to be used in a tank-mix with the post-emergence herbicide Bison 4L for post emergence control of annual grasses in small grain cereals and in selected forage grasses grown for seed only. ADDIT™ Adjuvant is to be used at 0.5% v/v with the recommended rate of Bison 4L as specified on the product label.

**PRECAUTIONS:**

**KEEP OUT OF REACH OF CHILDREN.**

Causes skin and mucous membrane irritation. DO NOT get on skin or eyes. Avoid contact with skin, eyes and clothing. Goggles, face shield and gloves should be worn when handling, mixing and loading. Wash concentrate from skin or eyes immediately. Avoid breathing vapours or spray mist. Avoid working in spray mist. After use, wash hands and other exposed skin thoroughly. Store the container tightly closed away from seeds, fertilizer, plants and foodstuffs. Avoid contamination of ponds, streams, rivers and other water sources. DO NOT APPLY BY AIR.

**FIRST AID**

If swallowed

Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

If on skin or clothing

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes

Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Contains petroleum distillates-vomiting may cause aspiration pneumonia. This product contains materials that may cause severe pneumonitis if aspirated. If ingestion has occurred less than 2 hours earlier, carry out careful gastric lavage. Treat symptomatically. Treat symptomatically for skin and eye irritation.

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer with the same product. Do not reuse this container for any other purpose.
