#### DIRECTIONS FOR USE

**APPLICATION DIRECTIONS:** Apply as a soil surface treatment. May be broadcast by ground equipment unless specified otherwise in the label. Use a band treatment between the rows after formation of edible parts. Do not contaminate edible portions of the plant. Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. May be applied to the following crops to protect from slugs and snails.

**VEGETABLES:** Asparagus, beans, cabbage, carrots, celery, cucumbers, lettuce, melons, onions, peas, peppers, potatoes, radishes, spinach, squash, tomatoes, turnips: Apply 22.4 - 44.8 kg per hectare.

**TREE CROPS:** Cherries, peaches, apples: Apply 22.4 - 44.8 kg per hectare.

**SMALL FRUIT:** Blackberries, strawberries, grapes: Apply 11.2 - 44.8 kg per hectare.

**TURF & ORNAMENTALS:** Ornamental greenhouses, ornamental planting, lawns: Normally apply 11.1 - 22.2 kg per hectare. Repeat treatment as necessary to maintain control.

Experience has shown most plants to be tolerant to Deadline M-Ps. However, on extremely tender plants, such as orchids, it is suggested the user of this product do a small test to determine any plant sensitivity before making a broadcast application over the plants.

For best results, apply in evening. Especially beneficial if applied following rain or watering. Apply every 3 to 4 weeks during growing season, or as needed, up to a maximum of 6 applications per year.

**THIS PRODUCT MUST NOT BE APPLIED DIRECTLY TO FOOD CROPS. DO NOT APPLY BY AIR. DO NOT APPLY BY GROUND APPLICATION METHODS WHICH RESULT IN DIRECT CONTACT OF PRODUCT WITH THE FOLIAGE OR EDIBLE PORTIONS OF FOOD CROPS. FOOD CROPS MAY NOT BE HARVESTED WITHIN 6 DAYS OF TREATMENT.**

#### PRECAUTIONS
