3. HAZARDS IDENTIFICATION

May cause eye and skin burns. Avoid contact with eyes, skin or clothing.

4. FIRST AID MEASURES

If on Skin: Take off contaminated clothing. Wash skin immediately with plenty of water. If redness, burning, or irritation develops, get medical attention.

If in Eyes: Hold eye open and rinse slowly and gently with water for 15 – 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Get medical attention.

If Swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless instructed to by poison control center or doctor. Do not give anything by mouth to an unconscious person.

If Inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible.
